- Any leaks must be repaired; the addition of large quantities of make-up water will affect our ability to properly balance your pool water.
- Pool must be accessible and free of swimmers at time of service.

Terms and Conditions

All American Pool will bill your credit card at the end of every month for 12 consecutive months, beginning April 10.

The following Terms and Conditions apply:

- This agreement covers all labor required to open, close, clean and provide the basic chemicals required to balance and sanitize your pool during the pool season.
- Any additional work not included in this agreement will be billed separately.
- If a monthly payment is not received on the due date, all services will immediately stop.
- The plan is interest free, but if a payment is not received, an interest rate of 18% annually will be added to any outstanding balance and service will cease till account is brought up to current standing.
- All American Pool reserves the right to end, change, or alter this agreement at any time with written notice to the client.
- The client can terminate this agreement at any time with written notice; client will be billed for services rendered at current non-program rates.

- This agreement will exist for 12 months from April 10. If you start this program mid-season the ending date will be April 15 the following season, and your monthly total will be calculated to end on that day.
- Client must adhere to the “Client Responsibilities”, if All American Pool is unable to perform its service (low water level, water on cover, inoperable equipment, swimmers, etc...) there will be a \$45.00 trip-charge billed to the next monthly billing.
- Prices are based on up to one hour of service, any additional service/maintenance due to storm clean up, party cleanup, or vandalism, etc..... will be billed at \$85.00 a man hour / per man.
- In the event of rain, storm conditions, or scheduling conflicts, etc..... All American Pool reserves the right to reschedule your service.
- All American Pool reserves the right to choose the day of the week to perform all scheduled services, though we will attempt to accommodate the needs of our clients as best as possible.
